#### **VPAS OFFICE**

The Administrative Services Department constitutes four different units of college services which includes the Business Office, Maintenance and Facilities Division, Human Resources Division, and Procurement and Property Management Office. Mario Ignacio has started in his new post as the new Director of PPMO. Director of Facilities and Maintenance, Mr. Francisco Mendiola came back and has started working full time running the division.

The college contracted Pohnpei Arts & Crafts to install new signs for buildings at the National campus which was completed this year. The signage project also included signs to be done for the interior of all 17 buildings at the National campus for emergency as indicated in our Emergency Management Plan document, signs for energy conservations, and other signs for the building which includes cell phone use, classroom rules, computer labs usage, and more.


VPAS was appointed to be the Acting President since July 4, 2022 during the period of the outbreak of the COVID-19 here in Pohnpei and Kosrae. More of the employees of the college both at the National, CTEC, and Kosrae campuses were out sick with the COVID-19. Our cooks were all gone sick also so we hired a vendor to cater takeout food for the RH students one week period until our cooks were able to be back to work. Special thank you to the Comptroller for her efforts in the arrangement of delivery of takeouts for breakfast, lunch and dinner for those days. Fortunately, classes were not yet started so timing was good for us to deal with the absences of the employees per the service areas on all three campuses.

In August 2022, FY 2024 Budget Guidelines was prepared and shared with the cabinet for their reviews prior to releasing it to the college for the budget development which will end sometimes in November to be ready for the board to review and approve in its December 2022 scheduled meeting.

TracDat Assessment Plan reports were generated by all divisions in the Administrative Services for planning purposes to know what is needed for the FY2024 budget development.

## FACILITIES & MAINTENANCE OFFICE

**<u>CTEC Technical Building</u>**: Project commencement on September 1, 2021, and is scheduled to be completed in August 2023. Current construction being done on footings, grade beams and columns. The project has been experiencing delays due the heavy rain and ground conditions.



**National Campus Student Center**: Bids for the said project closed on November 13, 2020 and only one bidder namely **"ABCOR Engineering and Construction"** submitted a bid and was awarded the project. After contract documents were prepared ABCOR delayed the siging of contract due the limited technical capacity to implement the project. Extensions were afforted to ABCOR to allow time due the COVID-19 retrictions to July 15, 2022 and further to July 31, 2022. However, ABCOR was still reluctant to sign the contract documents. As such the PMU recommended to terminate further negotiation efforts with ABCOR and proceeded to readvertise the project on August 6, and bid **closing on September 8, 2022.** 



**National Campus Teaching Clinic:** On July 6, 2022 Interim President received and notice of grant approval from US Department of Education for the construction of the National Campus Teaching Clinic. The grant approved amount is \$5.6 million. Following the approval the college met with FSM PMU office to seek assistance in implementation of the project. Following the meeting an MOU between COM-FSM and FSM Department of TC&I-PMU was prepared routed for signatures. Bid invitations for the **"Design & Build"** was advertised on July 11, and bid **closing on August 24, 2020.** 



Kosrae Campus Multi-Purpose Building: No progress on securing funding for the said project.

**<u>CHUUK CAMPUS (Nantaku site Development)</u>**: No progress progress on the Bid advertisement due to travel retrictions. No progress on access road issues.

<u>CTEC Lower Campus Parking lot Paving and Drop –off lane</u>: Lower Campus parking lot and drive way paving was completed in July 2022. This project is portion of the COM-FSM Infrastracture Upgrade projects. The Drop-off lane was completed in June 2022.

# **IMF Projects:**

The following projects funded under the Infrastructure Maintenance Funds include:

- <u>Chuuk Campus Bldg. K Library Roof Replace & Renovation Project</u> This project is completed was *completed on July 15, 2022*.
- 2. <u>CTEC Classrooms 1-4 Roof Replacement & Renovation & CTEC Administration Floor</u> <u>Repair and</u> –Project is placed on hold due to insufficient funding.

# **COVID-19 Projects Funded by the CARES ACT Funds:**

 <u>National Campus Perimeter Fencing Project</u> – National campus fencing project is currently @ 80% completion.

The Office of the Vice President of Administrative Services and Facilities and Maintenance is still working with Department of land to resolve the land issues. The Director of Maintenance recommends that the college seek legal advise from the from Steve Finnen in the event that matter pursued to the need for legal ramification in the future.

- 2. <u>Chuuk Campus Perimeter Fencing Project</u> Project was *completed on July 30, 2022.*
- 3. <u>Yap Campus Perimeter Fencing Project</u> Project was *comleted on July 18, 2022.*
- Yap Campus Onsite Electrical Distribution System with Backup Generator Inlcuding Change Order #1, the project is about 68% complete with the completion date on November 30, 2022.
- 5. <u>Kosrae Campus Perimeter Fencing Project</u> Contract fully signed and certified awaiting coordination of Notice To Proceed between Senny's Construction and Kosrae Campus.
- Kosrae Onsite Electrical Distribution System with Backup Generator No contractor expressing interest on the project. National Campus staff may be dispatched to perform the work.
- <u>CTEC Perimeter Fencing Project</u>: A & P Enterprises, Inc. commence the project on February 1, 2022. As this reporting the project ius about 15% completed. Shipment of fencing marterials arrived late therefore delaying progress on the project.

8. <u>EDA GREEN HOUSE</u>: The Center for Entrepreneurship Center executed a contract for four green houses funded through US EDA. The National Campus project is about 95% completed and materials of the units at Chuuk , Yap and Kosrae Campuses recently arrived in June 2022.
