  - VPIEQA attended the Accrediting Commission For Community and Junior Colleges (ACCJC), Western Association of Schools and Colleges (WASC) *Accreditation Standards Symposium* 23-24 April 2015. The first day was a preconference meeting for Accreditation Liaison Officers (ALOs) and the second was a detailed review of the newly adopted 2014 Standards I, II, III, and IV with focus on specific terms, key data, and compliance expectations.
  - With the exception of the April ACCJC, WASC and COM-FSM Board Meetings, VPIEQA is on educational leave to complete her Higher Education EdD doctoral thesis, *Transformational Leadership and Enhanced Employee Engagement: Relationship, Roles, Accreditation, and Capacity Building Implications*. Director of Information Technology, Gordon Segal, is acting VPIEQA in her absence.

## ITO Information Technology Office

Updates:

### **Network/Systems**

IT Office continues in our efforts of maintenance and expansion of systems to accommodate and support mission critical technology functions. All Campuses continue usage of their Internet services via ADSL, Single Mode Fiber optics and/or T1 technologies depending on location. Satellite uplinks via PACNET are still in use. Contract negotiations are currently underway for expansions of networks for improved services in Pohnpei, Yap and Chuuk campuses due to recent changes in infrastructure allowing for such expansions. Kosrae campus rates will remain the same, as fsmc infrastructure does not allow for further expansion at this time. The situation for Kosrae campus will continue to be monitored for potential network improvements as they become available.

### **Computer Labs**

Purchase of student support technology in computer labs and in support of networks for those labs continues on schedule. Chuuk and Kosrae campuses will soon both be receiving new equipment in student computer labs. New equipment should be in place and operational by the end of May 2015.

### **Student Information System (SIS)**

SIS functionality is good. IT continues to work with Office of Admissions Records and Retention (OARR) and IRPO for further reporting modifications and capabilities. Functionality and long term plans for the SIS will be discussed in upcoming meetings with users and consultants.

### **Web and Publications**

Website improvement efforts and news efforts are proceeding. Procedures for request for services have been modified and will soon be added to existing procedures to allow for improved levels of service for news, printing and publications efforts.
