#### **Summer 2013 Early Registration**

As of report, the college *early registered* **440** students with **2,206** credits (or equivalent to **367.67** full-time equivalent students). Table below shows these *distributions* by campus:

# Early Registration Statistics versus Summer 2013 Revenue Projections

The college's *overall* Summer 2013 early registration *statistics* as of April 18, 2013 is below the Summer 2013 revenue projections in *head-counts* and *registered credits* (*see* 2013 Summer operation budget and projected tuition fees) by 65.23% and 68.19%, respectively. #### Spring 2013 COM-FSM Entrance Test (COMET)

#### Students utilizing the college's Sports and Recreation facilities

The *Sports and Recreation* office's log recorded 377 *usages* of the weight lifting room, and 781 students participating in sports and activities facilitated by the office.

#### Transcripts and Certificates of Enrollment

During the *reporting period*, the Office of Admissions, Records and Retention (OARR) processed and released 319 academic transcripts of records to support students' applications for (a) admission to other higher education institutions, (b) scholarships, (c) employment, and (d) other purposes.

OARR also processed and released 29 certificates of enrollment to support students' applications for the FSM and State Scholarships.

#### **Spring 2013 Commencement Exercises**

The College's 57th Commencement Exercises is scheduled on May 22, 2013. Specific of the National and Pohnpei campuses, the graduation ceremonies will be held on the aforesaid date at the *main* gym of the FSM-China Friendship Sports Center, 9:00 A.M.

As of report, there were 240 students who applied for Spring 2013 graduation, college wide. Table below shows the distribution of these 240 students by programs and campus.

The foregoing *figures* do not include students *graduating* under the COM-FSM and University of Guam *baccalaureate partnership program in elementary education*. According to the *coordinator*, there were six *applicants* from COM-FSM National Campus, and one from Yap State Campus.

Initial degree audits were conducted to assess and evaluate the academic records of these 240 applicants for Spring 2013 graduation, and to determine if whether or not they can be advanced to candidacy. Final degree audits will be conducted on May 18-19, 2013 to determine eligibilities to graduate of those who were advanced to candidacy from their respective programs.

#### **Degrees and Certificates**

During the *reporting period*, OARR processed and released 102 degrees and 28 certificates of achievement to students who had successfully graduated from their respective programs.

#### **Counseling Office**

The National Campus Counseling Office' *reported* that it provided tutoring services *through* its A+ Center to 54 students. The office also provided the following assistance to students:

- 1. Appeals to the Financial Aid Committee especially for those students who were placed on financial aid suspension.
- 2. Scholarship information, and application forms.
- 3. Transfer information and procedures
- 4. Withdrawal from COM-FSM, and information for future readmission and financial aid requirements.
- 5. Counseling on EducationUSA.

The office also reported 47 visits by students seeking counseling on academic, discipline, personal, and transfer.

#### Counseling Office's Alcohol Awareness/Prevention Activity

The office also launched an *alcohol awareness/prevention* activity, and submitted 160 participants to a pre-and post tests. Results show a *significant percent* of the participants exhibited *increased knowledge* about the subject, i.e., 40% of the participants scored above the median in the pre-test, and 87% above the median in the post-test.

#### **Program Assessment and Program Review Procedures Manual**

The acting Vice President for Student Services has taken the lead of the working group tasked to draft the Program Assessment and Program Review Procedures Manual. Other members working group are (a) two members of the faculty of instruction, (b) the student services coordinator for Pohnpei Campus, and (c) the lead counselor.

Two *versions* of the *draft manual* had been transmitted to consultant David J. Adams of Sandy Ponds Associates for *comments, feedbacks, and recommendations*. The most recent version of the *draft manual* had been *sent* to the consultant *last* April 9, 2013, and *feedbacks and recommendations* were receive from the consultant, April 16, 2013.

As of report, the *working group* is introducing into the *draft manual* the consultant's recommendations after-which another *version* of the *draft manual* will be *transmitted* to the consultant by April 23, 2013 *thence* submission of the *manual* for usability testing.
