**ARTICULATION AGREEMENT
BETWEEN THE
UNIVERSITY OF IDAHO AT MOSCOW, IDAHO (USA)
AND THE
COLLEGE OF MICRONESIA, KOLONIA (FSM)**

This ARTICULATION AGREEMENT is entered into by and between the University of Idaho at Moscow, Idaho in the U.S. and the College of Micronesia at Kolonia, Pohnpei in the Federated States of Micronesia (FSM).

WITNESSETH THAT

WHEREAS, the University of Idaho at Moscow desires to provide students with a range of diverse high quality learning experiences and opportunities and; WHEREAS, it regards students from the Federated States of Micronesia and Pacific regions as an important clientele to its international efforts;

WHEREAS, the University of Idaho is fully accredited by the Northwest Association of Schools and Colleges, as well as other organizations that accredit specific programs;

WHEREAS, the College of Micronesia-FSM is fully accredited by the Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges;


WHEREAS, the University of Idaho and the College of Micronesia-FSM recognize the mutual benefits of the academic articulation and transfer of courses between the University of Idaho at Moscow and the College of Micronesia-FSM.


NOW, THEREFORE, in consideration of the terms and conditions stated below, the University of Idaho and the College of Micronesia-FSM agree as follows:


1. That the University of Idaho will evaluate for possible transfer of credits of the COLLEGE OF MICRONESIA-FSM courses (see attachment) to determine the equivalency to the applicable University of Idaho course requirements, according to the University of Idaho catalog current at the time of admission – including required minimum course grades.
2. That the terms of this agreement shall commence on the day of complete execution of this agreement by all signatories and shall continue in full force and effect thereafter for a period of five (5) years unless terminated by thirty (30) days written notice of either party to the other.
3. That addition and/or deletion to the course listing in Attachment can be executed by mutual agreement between both parties.
